## Non-compliance with the accessibility regulations

#### Third party tools

The site is built using DokuWiki, a third-party open source wiki platform. It is partially compliant with WCAG 2.1, but we are aware of some accessibility issues which would need to be fixed centrally by the developer.

#### These include:

- Low contrast foreground/background (1.4.3 Contrast)
- Some empty buttons or links (1.1.1 Non-text Content and 2.4.4 Link Purpose)
- Elements missing from ARIA menu (2.1.1 Keyboard and 4.1.2 Name, Role, Value)
- Use of accesskey shortcuts (2.4.1. Bypass Blocks)

We have made the decision to continue using DokuWiki, but will monitor any changes to its accessibility and revisit this as required. We will also contact the developer to establish whether there are any planned improvements to the above.

#### **Documents**

Some of our PDFs, Word documents and Excel spreadsheets are essential to providing our services. For example, we have PDFs with information on how customers can configure the govroam service.

Any new documents we publish will meet accessibility standards.
