A WCAG audit was done by a third-party: https://www.dokuwiki.org/wcag-audit Our testing was consistent with this report.

We have made the decision to continue using DokuWiki, but will monitor any changes to its accessibility and revisit this as required. We will also contact the developer to establish whether there are any planned improvements to the above.

Documents

Some of our PDFs, Word documents and Excel spreadsheets are essential to providing our services. For example, we have PDFs with information on how customers can configure the govroam service.
