This accessibility statement applies to wiki.govroam.uk.

This website is run by the govroam team at Jisc, using DokuWiki. The site is designed for use by nominated technical contacts at customer organisations.

We would like this site to be as accessible as possible. For example, that means you should be able to:

- Zoom up to 500% without losing content or functionality;
- Use keyboard shortcuts to navigate.
- Listen to most of the website using a screen reader.
- Navigate most of the website using speech recognition software.

## Technical information about this website’s accessibility

Jisc is committed to making its website accessible, in accordance with the Public Sector Bodies (Websites and Mobile Applications) (No. 2) Accessibility Regulations 2018.

### Compliance status

This website is partially compliant with the [Web Content Accessibility Guidelines version 2.1](#) AA standard, due to the non-compliances listed below.

## Non-accessible content

The content listed below is non-accessible for the following reasons.

### Non-compliance with the accessibility regulations

#### Third party tools

The site is built using DokuWiki, a third-party open source wiki platform. It is partially compliant with WCAG 2.1, but we are aware of some accessibility issues which would need to be fixed centrally by the developer.

These include:

- Unlabelled form control (1.1.1, 1.3.1, 2.4.6, 3.3.2)
- Low Contrast (1.4.3)
- No Page Regions (1.3.1, 2.4.1)
- Skipped heading level (1.3.1, 2.4.1, 2.4.6)
- Redundant Link (2.4.4)
- Accesskey (2.4.1)

We have made the decision to continue using DokuWiki, but will monitor any changes to its accessibility and revisit this as required. We will also contact the developer to establish whether there are any planned improvements to the above.

### Documents

Some of our PDFs, Word documents and Excel spreadsheets are essential to providing our services.

For example, we have PDFs with information on how customers can configure the govroam service.

Any new documents we publish will meet accessibility standards.

## Content that's not within the scope of the accessibility regulations

### Older PDFs and other documents

The accessibility regulations [do not require us to fix PDFs or other documents published before 23 September 2018](#) if they're not essential to providing our services. For example, we do not plan to fix our 'High Level Architecture' PDF.

Any new PDFs or Word documents we publish will meet accessibility standards.

## What we're doing to improve accessibility

We're committed to working on the issues outlined above, either by investigating our own solutions or by raising any accessibility issues with our third-party providers.

When updates are made to this site, we will ensure that they meet WCAG 2.1 AA.

## Preparation of this accessibility statement

This statement was prepared on 22/09/2020. It was last reviewed and updated on 01/08/2023.

This website was last tested on 01/08/2023. The test was carried out by a member of the govroam team.

We have tested a representative sample of pages, which reflect the content and features used across the site.
